Imazapyr	Habitat	Do not enter treated area for 24 hours	April – September
Chelated Copper Herbicides	Komeen, Current, Harpoon	No swimming for 24 hours	July – September
2,4-D	Navigate, Sculpin G	No swimming for 24 hours Do not irrigate ornamentals or food crops for 21 days after treatment or until an approved assay determines the concentration is less than 100 ppb. Do not drink treated lake water for 21 days after treatment or until an approved assay determines the concentration is less than 70 ppb.	May – September
Triclopyr	Navitrol, Navitrol DPF, Renovate 3, Renovate OTF	No swimming for 24 hours Do not irrigate ornamentals or food crops or water livestock for 120 days after treatment or until an approved assay determines the concentration is non-detectable.	May – September
Adjuvant	Cygnat Plus, AquaSticker	None	April – September
Water Dye	Cygnat Select Extreme, Blue Springs Dye	No swimming for 24 hours	April – September
